### SUNNYBANK PLAZA SHOPPING CENTRE AND SUNNY PARK SHOPPING CENTRE "SUNNYBANK \$2 FOOD TRAIL – WIN A SHARE IN OVER \$8000 WORTH OF PRIZES" PROMOTION TERMS AND CONDITIONS

- 1. These official rules ("**Rules**") apply to the "Sunnybank \$2 Food Trail Win a Share in over \$8000 Worth of Prizes" promotion ("**Promotion**") conducted by the Promoter for Sunnybank Plaza Shopping Centre and Sunny Park Shopping Centre ("**Centres**").
- 2. Information on how to enter forms part of these Rules. The Promoter may, at any time, amend, add to or delete any of these Rules.
- 3. Entry is deemed acceptance of these Rules including any changes made by the Promoter, even if the entry is before the publication of any changes to these Rules.
- 4. The Event Day is Saturday, 22 June 2019 ("**Event Day**").

### Eligibility

5.
